


#### Caste Cases – A Miraculous Recovery

Vet Bekky recently attended a 15 month old heifer, that decided to make a break out of the field, over a hedge and onto the main road! After road-side sedation and moving her to a safe location, the descison was made to cast the leg.

This fracture had all the risk factors – the break had potential joint involvement and the pateint was well over 200kg – but the fact the farmer reacted and called us promtly, the break was less than an hour old at point of casting will have made a sucsessful outcome a lot more achivable.

The greatest input to her recovery was undoubtably to excellent nursing care she received during the time she had a cast on. She was isolated in a deep bedded small pen to limit movment. The cast was kept clean and dry and was regulary checked for sores and slippage. After 4 weeks the cast was replaced as she had grow a lot during this time, and after a further 4 weeks it was reomved and she had made a full recovery!

### **Animal Health and Welfare Pathway**

Single farm payments will have disappeared by 2028, and DEFRA is not replacing like-for like. The way we are managing our animals needs to change- we need to make them as efficient as possible to help make up the shortfall that most will experience. Watching a 15-minute video will explain how you can work on improving the health of your stock and claim the following to spend on your vet farm visit:

- £436 per flock per year
- £522 per beef cattle herd per year
- £372 per dairy cattle herd per year
- £684 per pig unit per year

# Journey Along The Annual Health and Welfare Review...




**Knowledge (A2k)'** bar to open the video. If you fast forward to 11:30, the relevant talk is finished by 26:30.

During your funded farm visit, we will discuss any flock/herd health concerns, carry out priority disease testing, discuss the biosecurity you have on farm and the antibiotics and vaccines you have used over the last 12 months.

Currently, priority disease testing for each species will be:

- Wormer Check Test for flocks (are your wormers really working?)
- BVD screens for cattle
- PRSV investigations for pigs



In exchange for the funding, some information will be collected during the vet visit and fed back anonymously to DEFRA. DEFRA hope that they can build a better picture of the national herd and flock. We are hoping that it will help prove that UK farmers are excellent guardians of animal welfare and responsible users of antibiotics!

This money is part of the Sustainable Farming Incentive, applications to which opened on June 30<sup>th</sup>, 2022.
